

# **Estonian Imported Telecom-Grade Router PAM4**



## **Overview**

On March 23, 2026, the Federal Communications Commission enacted one of the most sweeping consumer technology restrictions in American regulatory history: a blanket prohibition on the import and sale of all new consumer-grade routers manufactured outside the United States. Routers are the boxes in every home that connect computers, phones, and smart devices to the internet. The decision, driven by a. On March 31, 2026, the Federal Communications Commission (FCC) updated its Frequently Asked Questions providing guidance on the agency's March 23, 2026 decision, adding “routers produced in a foreign country” to the Covered List — an action that banned approval of any new covered consumer-grade. From the FCC: “The FCC updated the Covered List following a thorough review by a White House-convened Executive Branch interagency body with appropriate national security expertise, which jointly and severally made a specific determination that routers produced in any foreign country pose. The Federal Communications Commission (“FCC”) has taken a significant and unprecedented step in its ongoing supply chain and national security initiative by adding consumer-grade routers produced in foreign countries to its Covered List. This action effectively prohibits the authorization—and.
