

Latest version of regulations for the export of optical fiber cables



Overview

IEC 60794-1-1:2023 applies to optical fibre cables for use with communication equipment and devices employing similar techniques. Electrical properties are specified for optical ground wire (OPGW) and optical phase conductor (OPPC) cables. These regulations are revised pursuant to provisions of the Foreign Relations Authorization Act, Public Law 107-228 (the Act). This Act authorizes the Secretary of Commerce, with the concurrence of the Secretary of State and the Secretary of Homeland Security, to publish regulations mandating that. On January 16, 2025, BIS published a rule titled "Implementation of Additional Due Diligence Measures for Advanced Computing Integrated Circuits; Amendments and Clarifications; and Extension of Comment Period", which included a timeline during which certain companies are considered authorized.
