Overview

Use this calculator to estimate customs duty and VAT (PDV) when importing goods into Serbia. The 35% US tariff rate represents the highest tariff burden imposed on any Balkan country, significantly impacting Serbia's export competitiveness in the American market. This dramatic increase from the previous 10% rate that was in effect until August 1, 2025, demonstrates the magnitude of change. Serbia calculates using the CIF method, which means the import duty and taxes are calculated based on the value of the imported goods as well as shipping costs. There are usually also charges levied by the import customs broker for filing the import. Beside harmonization of the nomenclature which comprises amendings of heading, tariff codes, Notes and Rules for the Interpretation of Customs Tariff, this regulation includes also the rates of customs duties, ie. products, such as dietary supplements, tractors, and heavy construction machinery remain a challenge when compared to EU competitors.
